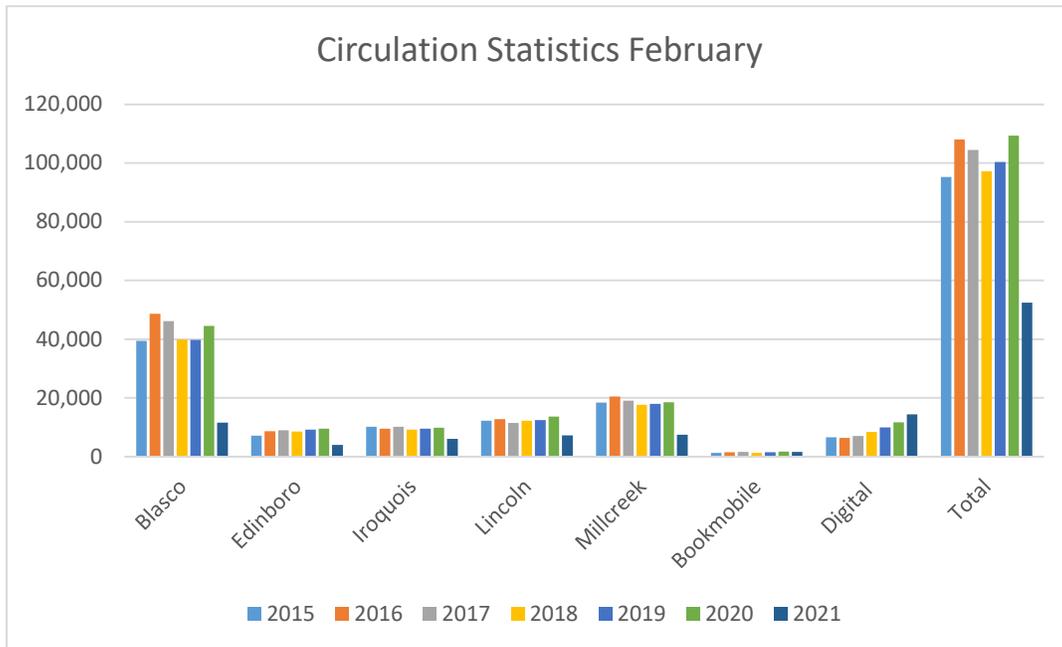

#### d. Report of District Consultant

##### **Northwest PA Innovation Beehive**

The NW PA Innovation Beehive, an entrepreneurial support network that includes Blasco’s Idea Lab as well as the universities of Gannon, Mercyhurst, Penn State Behrend, and Edinboro, is hitting the road! With a grant through the Appalachian Regional Commission (ARC), the Beehive looks to expand its services throughout the entire Northwest region of Pennsylvania and eventually cross state borders to New York and Ohio.

The district will play a role in connecting other public libraries with the Beehive’s mobile unit; Blasco’s role expands to now include a digital resource that will be accessible by anyone – a LibGuide that shares definitions, content, and resources for business-related topics like business basics, finance, intellectual property, marketing, and incorporation. Once prepared, libraries will be able to point patrons to it; patrons will be able to access it 24/7 in preparation for entering the Beehive cohorts.

##### **Annual Report**

All of the libraries have completed their initial annual reports. District consultants have until the beginning of April to fully review and submit library documentation to the Office of Commonwealth Libraries.

##### **Internet Funds**

There are a variety of funds becoming available to expand access to internet services. The libraries will play a role where feasible in encouraging the utility of these resources. In case you hear about them, here are brief descriptions.

Emergency Broadband Benefit Program (EBB): To help lower the cost of high-speed internet for eligible households during the on-going COVID-19 pandemic. Eligible households will be able to apply for the discounts on internet service. Guidelines and other details to be released soon.

Emergency Connectivity Fund (ECF): To provide funding to schools and libraries that provide Internet connectivity to off-campus locations, such as to homes of students and library patrons. The Fund will also support related equipment such as hotspots, routers, and modem hardware, as well as “connected devices” like laptops or tablets. Guidelines to be released later this spring.

Governor’s Emergency Education Relief (GEER): The GEER program is looking at Crawford County as a potential county to work with their libraries on strengthening connectivity at some of their library system’s facilities. Crawford County initially made the list due to its economically distressed status and areas that lack internet access.

While it may be out of the realm of public libraries to solve all broadband needs, we can at least explore and encourage the initiatives that are surfacing. More details to come.

**FORGOTTEN CARDS**

Patrons who have forgotten their cards may borrow materials or use the Internet if they provide identification and/or verify security questions.

Patrons who are not able to verify their identity may not borrow library materials or use the Internet.

**LOST CARDS**

Lost cards will be replaced at no charge. Replacement cards carry over all fines, fees and circulation information from the previous card.

**DAMAGED CARDS**

Damaged cards will be replaced at no charge. Replacement cards carry over all fines, fees and checkouts from the previous card.

Non Erie-County residents enrolled at a local higher education institution or seasonal residents may register for an ECPL card provided they present a current college identification card or proof of seasonal residence, including an official letter, and another acceptable form of identification that shows the permanent home address. Out-of-state and International students are also eligible for registration may register for a card providing they present current identification and provide a local address.

A college-student card is valid from one-year library and must be renewed annually.  
There is no fee for this card.

Patrons who live at temporary residences may register for an Erie County Public Library card provided they present a signed letter on letterhead by an officer of the agency operating the premises at which they reside indicating that he or she lives there or valid PA state ID. The letter should be dated no longer than one week prior to the date the patron applies for the card. If the patron is a resident of a motel or hotel, he or she must have a recently dated rent receipt as proof of their residence.

A temporary residence card is issued for a three-month period and can be extended provided that proof of residence is presented at expiration time. In addition, the temporary resident card will have a limit of five checked out titles.

There is no fee for this card.

Temporary resident patrons have access to library databases, but are not eligible for interlibrary loan services.

Out-of-state patrons and patrons from areas in Pennsylvania that do not participate in Access PA may apply for a non-resident card.

Library card applicants can apply for a temporary online card on the Library's website at [www.erielibrary.org](http://www.erielibrary.org) or complete an application form in person at any outlet of the Erie County Public Library.

A non-resident card is issued for a one-year period and can be extended provided that proof of residence is presented at expiration time. The non-resident card will have a limit of 25 checked out titles.

There is a \$10.00 annual fee for non-resident cards.

Proof of name and current mailing address, in accordance with the library's current list of acceptable identification, as well as a signature accepting responsibility for borrowed materials are required. For minors age 15 and under, parent or legal guardian identification is required.

Non-resident patrons are ineligible for Interlibrary loan services.

Students of local higher education institutions are exempt from this policy and receive a card as outlined in policy number 716, REGISTRATION AND USE OF LIBRARY CARD, COLLEGE STUDENTS.

Erie-County residents employed by any K-12 institution or childcare provider may apply for and receive a Teacher Card. Elementary, middle or high school educators or child care providers, student teachers and other individuals who work in early childhood or daycare centers are eligible for a Teacher Card. A Teacher Card is an additional card that allows you to keep your personal borrowing separate from the items borrowed for classroom use.

A Teacher Card may be used at any Erie County Public Library location and normal fines apply as per library policy. As the borrower you are responsible for the items on this card, however keeping items separate will assist you if you need to seek reimbursement from your school or organization for lost or damaged items.

To obtain a teacher card, a letter on institutional letterhead signed by the principal or director indicating your status as an employee for the current or upcoming school year or a recent pay-stub that includes your name, current address and school along with a current ID. This card must be renewed every year at any ECPL location.

The borrowing limit on this card is 125 items. There is no fee for this card.

g. Revised Policy 722

Erie-County residents who homeschool may apply for and receive a Homeschool Card. A Homeschool Card is an additional card that allows you to keep your personal borrowing separate from the items borrowed for home instruction. Homeschool parents, guardians, or educators must show proof of Erie County residency and proof that they are homeschooling.

Homeschooling educators may apply for a Homeschool Card upon presentation of a Home Education Affidavit, as defined by the Pennsylvania Department of Education and issued by the local school district, or by providing proof of being a current properly qualified private tutor.

A Homeschool Card may be used at any Erie County Public Library location and normal fines apply as per library policy. As the borrower, you are responsible for the items on this card.

This card must be renewed annually at any ECPL location.

The borrowing limit on this card is 125 items. There is no fee for this card.

If a patron owes more than an amount to be determined by the library in fines and fees, no additional materials may be borrowed until the amount owed is brought to under the determined amount. The library has the sole discretion to determine what the blocking amount will be.

If a patron has one or more overdue items with more than the determined in fines or fees, they may not be eligible to borrow any additional items until all overdue items are returned. Borrowing eligibility is determined by total fine amount incurred.

Patrons may still access the public Internet computers.

## **Erie County Public Library Set to Reopen March 8**

COVID-19 mitigations will be in place for patrons following Dept. of Health guidelines

Erie County officials have agreed to reopen all public library facilities after thereopening of the Erie County Courthouse, according to [a release](#) by the Erie CountyPublic Library (ECPL). Partnering with the Erie County Department of Health, librarystaff will have the health and safety of the public at the front of any decisions onhelping stop the spread of the novel coronavirus.

The release notes the ECPL will stay open barring any increase in local COVID-19cases, at which point decisions will be made based on advice from the Erie CountyDepartment of Health.

Sheryl Thomas, ECPL Assistant Director, said the staff is "a little nervous but veryhappy to be opening our doors again and welcoming back our patrons." Thomasnoted that while the ECPL facilities have been providing curbside options for patrons,seeing familiar faces and providing full access to the facilities "will be a very niceboost."

"Patrons are excited to be returning and able to browse through the book stacks to find favorite and new titles," said Thomas.

Patrons can expect mitigation efforts to include: 50% occupancy limit, required face covers, limited equipment and occupancy within the Blasco Libraryfacilities, and contactless outdoor book drops. Services such as the childrens' play areas at each location and in-person programming and events willnot be offered at this time. Virtual programming and online resources are still available via the ECPL website at [erielibrary.org](http://erielibrary.org). Curbside services willresume as library staffing allows.

"We appreciate the support and patience of the community and look forward to seeing individuals (with mandatory masking) come back to use theirlibrary," said Thomas.

Library lovers can head back to the stacks at Erie County Public Library locations starting Monday, but there are guidelines to keep in mind in the interest of employee, personal and public safety.

The library's branches closed Nov. 18 because of a surge in COVID-19 cases. Customers have since had to call the library to reserve books and other materials, then pick them up at curbside.

But Erie County announced this past week that the libraries, and the Erie County Courthouse, would reopen Monday. The county said the library expects to remain open as long as COVID-19 case counts remain "sustainable" It was time': As COVID numbers fall, Erie County Courthouse, libraries to reopen March 8

Most pre-pandemic services will be restored starting Monday, library system officials said in a news release, but a number of safety measures are in effect at all locations:

- ▶ Each location will enforce a 50% occupancy limit.
- ▶ Use of face coverings and social distancing is required.
- ▶ All material collections are available for browsing.
- ▶ Computer stations are available at all locations. Blasco Library's internet lab has been relocated and outfitted in accordance with the Blasco Master Plan. Patrons may reserve 60-minute sessions.
- ▶ Blasco Library's Heritage Room will offer limited equipment and occupancy limits.
- ▶ Blasco Library's Idea Lab will offer limited equipment and reservation-based services.
- ▶ Blasco Library's Collaboratories will be available for patron reservation. Face coverings are required to be worn at all times.
- ▶ Public restrooms and drinking fountains in the lobby and children's areas (family use only) are available for patrons to use at their own risk.
- ▶ Professional cleaning occurs daily at all locations. Cleaning and hand sanitizing stations are available for patrons to use throughout their visit.
- ▶ Patrons are encouraged to return all items to contactless outdoor book drop-offs that are open 24 hours.

Some services remain unavailable

- ▶ Children's play areas and toys at all library locations.
- ▶ One-on-one patron assistance that cannot be accomplished while practicing social distancing. This includes one-on-one computer assistance, extended research and genealogy and equipment/device assistance. Patrons are encouraged to bring a helper from their household should they require assistance that cannot be completed from a 6-foot distance by staff.
- ▶ In-person programming and events. Find the library's virtual programs calendar at [events.erielibrary.org](https://erielibrary.org).
- ▶ The café located in the lobby of Blasco Library, K&P Concession, will remain closed until further notice after the death of longtime hostess Penny Greco in February.

- ▶ Wi-Fi access has been extended to parking lots at all locations.
- ▶ Curbside service will be provided as staffing allows, with preference given to those patrons unable to adhere to the face covering order. Please call your local library in advance to discuss pickup options.
- ▶ Peer navigators will return in the weeks following reopening to Blasco Library, providing social services for patrons in need of assistance.

McCord Memorial Library, 32 W. Main St., North East, also will reopen Monday, as will Union City Public Library. Those two, the county's other independent nonprofit libraries and the county system branches form the Public Libraries of Erie County.

The PLEC's Integrated Library System allows county residents to obtain a card at any library outlet; access collections at all locations; borrow from and return to any library in the county (with a few limited exceptions, including inter-library loan); pick up materials at the library of choice; use the online catalog to find and place holds on library materials at all locations; and use the public access computers at any PLEC library.

## **A Step Towards Normalcy, Erie County Courthouse and Library Reopens**

The Erie County Public Library and the Erie County Courthouse closes a chapter and turns a new page Monday, reopening to the public for the first time in months since the coronavirus pandemic. Residents are excited for a sense of normalcy.

"It makes me feel like things are getting back to a bit of normalcy. I've really missed it" said Steve and Jane Kuhn, Millcreek residents.

The Raymond Blasco location has already filled up with residents. To safely accommodate everyone, there's new socially distant work stations and face masks are mandatory. Sheryl Thomas, the Assistant Director of the Erie County Public Library told Erie News Now on this afternoon, that safety is priority which why in-person programs will remain digital until further notice.

"As restrictions ease and case numbers drop, we'll be able to do in person programming at some point so that'll be really exciting," said Sheryl Thomas, Assistant Director of the Erie County Public Library.

As for the Erie County Courthouse, residents can now come in and out of the courthouse to handle court related needs. Erie County President Judge Joseph Walsh said as long as there isn't another spike in cases, the county courthouse will continue to stay open to the public.

"That's our top priority to keep this place as safe as possible. This is good for the public simply because they don't have to schedule appointments to come in and take care of business" said Joseph Walsh, President Judge of Erie County.

According to Walsh, the courthouse is following CDC guidelines to keep residents and employees

safe.

The Erie County Courthouse and Erie County Public Library are set to reopen to the public a week from today on Monday, March 8.

The Erie County government announced Friday its plans to reopen the county courthouse and library to the public on March 8, but the administration noted it will continue to monitor the COVID-19 pandemic and make any necessary concessions.

All civil or criminal court hearings and appointments in Erie County will continue as scheduled. Any questions related to the county's courts should be directed to 814-451-6295.

Even though the Erie County Courthouse, 140 W. 6th St., Erie, is reopening its doors to the public, residents are encouraged to continue utilizing electronic services through the county's website, [www.eriecountypa.gov](http://www.eriecountypa.gov), and to meet virtually whenever possible.

"The administration and court administration continue to observe safety protocols for the public and county employees, and we believe operations can now resume," Erie County Director of Administration Gary N. Lee said. "Please continue to wear masks, keep a 6-foot distance from others, wash hands frequently, limit gatherings and stay home when feeling ill."

Members of the public are encouraged to check the county's website for further updates.

In following the lead of the Erie County Courthouse, all Erie County Public Library facilities will fully reopen to the public on Monday, March 8.

The county library has partnered with the Erie County Department of Health to ensure that the reopening responsibly considers the safety of patrons and staff and adheres to all local, state and national guidance.

Erie County Library, which is headquartered at 160 E. Front St., Erie, expects to remain open as long as local COVID-19 case numbers remain sustainable and the library will make any adjustments as necessary based on the advice of the health department.
